- 1. Read the Marvin J. Christiansen Advisor Contest guidelines.
- 2. Complete and compile an E-Portfolio. The E-Portfolio must include a cover page, nomination form, and supporting document. Please remember that all documentation must be in PDF form.
- E-mail the E-Portfolio to the CNH Contest Archive (<u>cnh.kccontest@gmail.com</u>). Submissions must be <u>received</u> Tuesday, February 16th, 2021 by 11:59PM PST/HST.

MARVIN J. CHRISTIANSEN ADVISOR GUIDELINES

RULES GOVERNING THE CNH KEY CLUB MARVIN J. CHRISTIANSEN ADVISOR AWARD

The Marvin J. Christiansen Advisor Award recognizes the achievements of a Kiwanis Advisor serving the California-Nevada-Hawaii Key Club District. It is the highest recognition award presented to a Kiwanis Advisor at the CNH Key Club District level.

- (1) OVERVIEW:
 - Any member in good standing with the California-Nevada-Hawaii (CNH) District and Key Club International will be
 eligible to nominate a Kiwanis advisor for his or her contributions made for the CNH district.
 - The candidate (advisor) must have been an active district-level advisor for at least five years.
 - The candidate must have noticeably served the CNH District.
- (2) E-SIGNATURES: This application requires electronic signatures (e-signatures) by the applicant and Faculty or Kiwanis Advisor. E-Signatures for this application are defined as names and contact information provided into the form. E-Signatures display that the individuals listed have approved the application and supporting documentation. These individuals may be contacted for further verification. Please do not use

digital signatures or actual signatures. Please type the name of the individual who approves in the appropriate locations for signatures.

- (3) **E-PORTFOLIO:** The final submission for this contest includes an E-Portfolio. An E-Portfolio for this application is defined as one collective portfolio presenting the <u>best pieces</u> of documentation. This E-Portfolio should be a single PDF that includes all merged information
- (4) **SMALL FILE SIZES:** Application submissions should have a small file size. Files may not exceed 10MB. The following are tips to maintaining this:
 - Include only the <u>best</u> samples of documentation
 - Compress all <u>photos</u> and <u>files</u> before use in e-portfolio
 - Compress the <u>final</u> e-portfolio file
- (5) The committee may select only one individual for this award. If no candidates are deemed worthy, this award will not be presented for that year. No one may receive this recognition more than once. Suitable awards will be presented.
- (6) Submissions are final. The decisions of the judges are final. No changes or re-evaluation will take places after the judges and the Member Recognition Chair have certified the results.
- (7) An appropriate contest application (report) requires the submission of the following supporting documentation. The report may showcase the candidate's activities and accomplishments spanning a minimum of five years as a CNH Key Club district-level Kiwanis advisor.
 - The entire submission needs to be given in <u>one</u>E-Portfolio. o It may not exceed 10MB.
 - Save as a PDF. Label the file: Marvin J. Christiansen_LastNameFirstName
 - All required items for the E-Portfolio are listed on Page 2.

MARVIN J. CHRISTIANSEN ADVISOR RUBRIC

1) Cover Page Page Limit: 1

- a) Name of Nominee
- b) Position and Term
- c) Home Club, Division, and Region
- d) Picture of Applicant

2) Nomination Form

Page Limit: 2 | (5 pts max)

- a) Name of Nominee
- b) Home Club, Club Number, Division, and Region
- c) Name of Nominator
- d) Table of Contents
- e) Statement of Nomination | Word Limit: 1,000

3) Dividers

Page Limit: 8 | (5 pts max)

A one-page divider is required to precede each section. It should contain the following information:

- a) Section Title with a personal reflection
- Personal Reflection: addresses personal growth, accomplishments, explanation of section, list of evidence not included, or other details that may assist judges in determining scoring.

4) Letter(s) of Recommendation

Page Limit: 3 | (10 pts max)

a) These are used as testimonies to support the overall E-Portfolio. Letters will portray the efforts the applicant set forth to serving as a Kiwanis Advisor on the district level.

5) Mentor – Commitment to Helping District Officers and Members

Page Limit: 10 | (10 pts max)

a) Showcase how the applicant has been instrumental as a mentor and advisor to the district officers, district board members, club officers, and members.

6) Commitment to the Key Club Core Values Page Limit: 10 | (10 pts max)

- a) The Key Club International core values include caring, character building, inclusiveness, and leadership. A Marvin J. Christiansen Award nominee should have demonstrated all core values throughout his/her service on the district level.
- b) Make sure that this form is certified by the Club President, Club Secretary, or Club Advisor.

7) District Achievements

- Page Limit: 6| (20 pts max)
 - a) Identify all of the District's achievements, challenges and obstacles, growth, and any other commendable achievements that were influenced by the mentorship of the advisor.

8) Personal Contributions

Page Limit: 6| (15 pts max)

a) Showcase how the applicant distinguished himself/herself by making the most of his or her opportunities.

Kiwanis Family – Fellowship & Unity

Page Limit: 3

 b) Showcase the applicant's active participation in establishing relationships as a member of the Kiwanis Family.

9) Inspirational Qualities

Page Limit: 4 | (10 pts max)

a) Showcase how the applicant has been an inspiration to others by providing any additional information that will assist the judges in this evaluation process.

10)Graphic Standards | (10 pts)

a) Your E-Portfolio will be judged on sections 1 through 10. As a whole, it must demonstrate your knowledge of **Graphic Standards**.

11)File Size | (5 pts)

a) If the E-Portfolio **file** must not exceed 10 MB and 54 pages, it will earn **5 points**.

1. Under Submission Deadline, What does "CC yourself" mean?

When composing the email, on the right side of the "To" box, there will BCC and CC, push the CC and type in your email, that way you have a Carbon Copy for yourself.

2. How do I do receive an E-Signature?

Send an email to respective people you would like to receive signatures from, asking permission whether you may include their names as proof of your efforts. After their approval, you may input their names. There is no physical signature. It is the name and contact information of the necessary individuals, <u>typed</u>.

Only advisors serving the California Nevada-Hawaii District may apply for the Marvin J. Christiansen Award. Read the above guidelines for more details. If you do hold an elected or appointed position, such as President, then you may not sign off on your own sheet.

4. How do I compress my PDF files/pictures?

(Keep in mind, a "JPEG" photo is already small enough, and would not need any compressions).

5. How would I go about creating my E-Portfolio?

Google Slides is a good and free application to use; you can also use Publisher, Word, Photoshop, and PowerPoint. When saving a file in Google Slides, go to "File", then "Download" and you will see the PDF option. To find more information on how to make an e-portfolio visit the <u>CNH Youtube Channel</u>.

6. How do I transfer the forms on this file, such as the nomination form, to my e-portfolio?

There are multiple ways you can transfer the ways, but here are some easier ways. You can access the google slides links to the single PDF files of each form in the rubric. Then, you would press file > make a copy. Now, you can fill out the form and copy and paste the slide into your e-portfolio. Other ways include using Adobe Acrobat with the single file PDFs in the rubric or using Microsoft Word.
