- Kiwanis Advisor of the Year

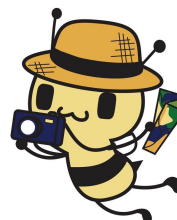
Club Contests

OFFICIAL EVENT

Each Lieutenant Governor (LTG) is responsible for hosting a Division Judging for contests that are judged on the division level.

Hosting a Division Judging is simple and easy with proper planning!

THINGS TO NOTE:

Consistency

Judging is a serious job.

If you're feeling tired or incapable of performing at your best, take a break. There is no excuse for inattentiveness.

Neutrality

Judging should be conducted as objectively as possible.

Before judging an applicant, make sure you have read his or her application in its entirety.

Judges may not review an application from their clubs.

Humanity

Numbers are not everything!

Yes, you are judging the content of the entry, but also take into account the effort and insight of the entry.

Remember to respect the applicant's hours of hard work and determination in applying for a contest.

DIVISION JUDGING COMMITTEE (DJC)

REQUIREMENTS WHEN ASSEMBLING THE DIVISION JUDGING COMMITTEE

- **At least one-third of the clubs** in a Division need to be represented in the DJC.
- **At least half** of the DJC members must be **non-elected/non-appointed** Key Club members.
- Membership in the DJC is **voluntary**. LTGs may not coerce people to join.
- Judging can take place **in person** or **online**!
- DJCs must have no fewer than 6 members and no more than 12
- **A judging application and waiver form have been made for all LTGs to use in selecting members for a DJC. They can be found on the CNH Cyberkey under Recognition > Judging.**

Exceeds	13-20	In order to qualify for the "Exceeds" category, apparel must include the proper Key Club logos (District, International, and other word art). Apparel also should include other words promoting aspects of Key Club as an organization.
Meets	7-12	In order to qualify for the "Meets" category, apparel has included some of the proper Key Club logos (District, International, and other word art). Apparel also attempts to include other words promoting aspects of Key Club as an organization.

Approaching	5-9	In order to qualify for the "Approaching" category, the design is similar to other designs. There are only minor changes compared to the original. There must be no copyright infringement.
Below	0-4	The design is a copy or or extremely similar to other designs. There is a copyright infringement.

Meets	6-8	In order to qualify for the "Meets" category, there should be a significant amount of money fundraised by the club in total (over \$100), as well as a variety of fundraisers (at least 2) and these fundraisers should be supporting different preferred charities.

Meets	18-24	In order to qualify for the "Meets" category, the essay must describe and document, with a few details, the efforts undertaken by the club to promote the core values of Key Club (3-4), celebrate outstanding member (3-4), disseminate useful information (3-4), encourage district involvement (3-4), implement useful and unique service projects (3-4), and promote a respect for Key Club core values and spirit (3-4).

	5	Divider Pages Reflections
Exceeds	5	In order to qualify for the "Exceeds" category, the Divider Pages needs to have a reflection, not just a description. The Applicant should reflect upon what the section is about, as well as how they grew as a Key Clubber because of what is being covered in the section. In order to earn exceeds, the applicant needs a reflection in every new section.
Meets	3	In order to qualify for the "Meets" category, the Divider Pages need to contain mostly reflections, with little to no descriptions. The Applicant should reflect upon what the section is about, as well as how they grew as a Key Clubber because of what is being covered in the section. In order to earn meets, there needs to be a reflection in most new sections.
Approaching	1-2	In order to qualify for the "Approaching" category, the Divider Pages need to contain reflection and/or descriptions of the following section.

Exceeds	9-10	In order to qualify for the "Exceeds" category, this member should have four specific examples of how they demonstrated the core values throughout the year.

Approaching	4-6	In order to qualify for the "Approaching" category, this member should have one specific examples of how they demonstrated some of the core values.
